Each nomination form should be put in a separate cover. List of valid nominations (which are properly proposed, seconded and accepted without any overwriting/ conditions) will be **displayed at 1230 hrs on Wednesday the 30th November 2011** on the Notice Board in the Office of the Institute.
4. A candidate may **withdraw his candidature** by notice in writing addressed to the undersigned and delivered to the Institute's office **latest by 1230 hrs on Thursday the 1st December 2011.** The notice of withdrawal of candidature once given shall be irrevocable.
